# Small Spill:

#### **Precautions:**

Eye contact causes blepharospasm, purple staining of the cornea and conjunctivacause permanent corneal/eye damage. Inhalation: May be harmful if inhaled. May cause upper respiratory tract and mucous membrane irritration. Ingestion: Harmful if swallowed! Causes gastrointestinal tract irritation with nausea, vomiting, hypermotility, diarrhea, abdominal pain. May affect respiration (acute pulmonary edema), behavior (ataxia)Severe systemic poisonings have not been repeated in humans, but animal studies have shown blood pressure rise and death from respiratory paralysis during IV administration. Chronic Potential Health Effects: Ingestion: Prologned or repeated ingestion may cause peritonitis and may affect metabolism (weight loss).
