CITI Human Research Training

Any person affiliated with West Liberty University that will be conducting research with human participants is required to complete ethics training.

<u>CITI</u> (Collaborative Institutional Training Initiative) is the provider for the training.

The required training for conducting research with people is the Human Subjects Research: **"Social Behavioral Educational (SBE) Basic course**"

Additional ethics training may be required depending on the type of research proposal (i.e. biomedical). Contact the WLU IRB chair for more information.

A pdf file of the completion certificate(s) should be kept for your records. Proof of completion is required as part of the WLU IRB application process.

After three years, additional training / refresher course(s), may be required.

How to register and complete CITI training

The following pages include step by step instructions on how to register and sign up for the required training. The course typically requires about 3 hours to complete.
